



Visitor information

1 **Always** adhere to the site speed limits. Follow the signs in car parks. Watch out for cyclists and pedestrians. **Do not** use mobile phones whilst driving.



2 It is **important** to obey any signs or notices when on site as certain safety and health precautions must be taken before entering certain areas.



3 **Keep** to the designated walkways and pedestrian crossings. **Do not** use mobile phones when using stairs and do not run.



4 Smoking/vaping is **not permitted** other than in designated areas.



5 Drinking **alcohol is not permitted** on this site.



6 Put waste in designated bins and **recycle** where possible.



7 Visitors **must** remain with their host. In an emergency, follow your host and evacuate the building immediately to the assembly point.



8 **No photography or audio/video** recordings may be taken without prior authorisation. CCTV is in operation.



9 **Always** clearly display your visitor badge. Hand your badge back to Reception on your departure. Report anything suspicious to the host or Security immediately. Anti-social behaviour will not be tolerated.



10 **Report** any accidents/incidents to the host who will arrange appropriate first aid treatment. Should urgent assistance be required, then the site emergency number is below.



Life Saving Rules

GSK's Life Saving Rules are here to make sure everyone goes home safe. No exceptions.

There are 3 Universal Rules that apply to everyone that attends a GSK site.

They include proactive actions we must all take to keep ourselves and others safe.

Please take the time to read, understand and follow these Life Saving Rules while you are on site. If you see anyone not following a Life Saving Rule, please notify your host.

01. Safe workplace



- I do not use my phone or other devices when on the stairs and use handrails where available.
- I use designated pedestrian routes and crossing points when moving around my workplace.
- I report and take action if I identify anything that could cause harm to myself and others.
- I never ignore a safety alarm.
- I know my nearest fire exit and understand the fire evacuation procedures.

I understand and follow workplace safety rules.

02. Driving



- I plan my journeys in advance and only start a journey if I am fit to drive
- I always wear my seat belt when travelling in a vehicle and my helmet when riding a motorcycle
- I never use a hand-held or hands-free phone, or programme any other device while driving
- I obey traffic rules and stay within speed limits

I always wear a seat belt or helmet and never use devices while driving.

03. Moving objects



- I establish and obey exclusion zones around areas where moving objects could cause harm
- I position myself to avoid:
 - Moving options
 - Vehicle and goods movers
 - Moving machinery
 - Dropping objects and suspended loads
- I secure loose objects to prevent them falling

I keep myself and others out of the line of moving objects.
